



**8. ENTRIES:** Open on: 1ST / 03 / 10 Close at: 5.00 p.m. on 21/ 03 / 10

- a) Maximum number of driver entries for the Event: 50 Reserves: 4
- b) Maximum number of drivers per competitor: 2
- c) For Multi-club Hillclimb's. Entries are open to members of all CAMS affiliated clubs.
- d) The organiser reserves the right to refuse entry to any competitor in accordance with NCR 83.

**9. ENTRY FEE** will be: \$110.00 (GST incl) JUNIORS : \$55.00

**10. MINIMUM LICENCES:**

Current CAMS Level 2S Licence and current club membership card of a CAMS-affiliated car club are compulsory and must be produced at the Event.

**11. EVENT FORMAT:**

SCRUTINY will be held at: Bulahdelah GOLF CLUB on Saturday 27<sup>th</sup> March 2010 from 1:30pm to 4:30pm also Sunday 28<sup>th</sup> March 2010 from 6:30 am-9:00am at the venue, by arrangement with the Clerk of The Course (for those entrants who can not attend Saturday session a minimal number will only be allowed)

- a) All vehicles must comply with Schedules A & B of the CAMS General Requirements for Automobiles (as specified in the CAMS Manual), including a fire extinguisher; blue triangle (for battery) and a secondary method for fastening the bonnet.
- b) Maximum noise limit: 95 **dba** at: 30 **metres**. Any car found to exceed the maximum noise emission limit will be suspended from the Event until the Chief Scrutineer / Clerk of the Course is satisfied that action has been taken to bring it within the limit.
- c) Competition numbers are to be positioned on both sides of the car
- d) Drivers and vehicles must be presented in a clean and tidy manner. Note: The Event will not be delayed due to late arrivals. It is the drivers' responsibility to ensure their vehicles are scrutineered before the scheduled starting time of the Event. Drivers must attend scrutineering personally so that their driving apparel can be checked. DRIVERS' BRIEFING will be held at: 930**a.m.** It is compulsory for **ALL drivers to attend.**

Note: A driver "sign-on" sheet must be signed by all drivers to prove briefing attendance, failure to sign on may result in penalties being applied by the stewards of the meeting. The EVENT

commences at: 10:00 am and finishes at: 4:30 pm (appr.)

## 12. VEHICLE CATEGORIES AND CLASSES:

As per: CAMS Manual. The organiser may re-classify any vehicle if they believe it is not eligible for the category/type or class in which it has been entered.

With the addition of **Clubman Sports - as per NAMS speed event rules.**

**13. FUEL:** All competitors are permitted to use any fuel as defined in schedule G in the 2008 CAMS Manual of Motor Sport. **Vehicles running on alcohol** shall have signage indicating the use as is prescribed in Schedule G. Item 5.3

## 14. DRIVER SAFETY:

Drivers must wear:

- a) A helmet that complies with AS1698 or better (as per the current CAMS Manual of Motorsport) and carries marking to that effect, or is otherwise specifically approved by CAMS.
- b) Non-flammable clothing, including cover from throat to wrists to ankles (apparel of **nylon or similar** material is forbidden). Flame retardant overalls, or better, are highly recommended
- c) Suitable **flame retardant footwear** (thongs, open sandals, high-heeled shoes and **nylon joggers** are forbidden), and
- d) In open cars, goggles or a visor with a lens material other than glass (to AS1609) are mandatory as are leather or Nomex gloves which entirely cover the hands.

**15. REPLACEMENT VEHICLES:** At the sole discretion of the Clerk of the Course, a driver whose vehicle has broken down may use a replacement vehicle. The replacement vehicle must have been scrutineered, and preferably be in the same category/type and class as the original vehicle. Where the original vehicle has recorded a time and the scrutineered replacement is not in the same category/type and class as the original vehicle, the replacement vehicle will not be eligible for prizes and/or trophies.

**16. TIMING EQUIPMENT:** Our new timing equipment will be in operation & will be: within an accuracy of: 100<sup>th</sup> of a second

**17. RE RUNS:** Re runs will be permitted at the sole discretion of the Clerk of the Course. A restart will only be permitted if the rear wheels have not crossed the start line, if a red flag is displayed on the hill or a miss time occurs. If required it cannot be run before 5 other vehicles have had their runs.

**18. AWARDS** will be presented at MLMSC presentation night November (date TBA) 2010 and will consist of Trophies 1<sup>st</sup> 2<sup>nd</sup> 3<sup>rd</sup> outright and first in class.( A class must have a minimum of 3 entries to qualify) **PLEASE NOTE:CLERK OF THE COURSE SPECIAL AWARDS** for Juniors &, Ladies,

19. **AUTHORITY OF OFFICIALS:** Any driver not following a reasonable instruction by an official during the Event may be excluded from the Event at the discretion of the Stewards of the Meeting.

20. **MEDICAL FACILITIES:** Fully Qualified Paramedic, First Aid Attendants.

21. **CRASH RESCUE AND FIRE FIGHTING FACILITIES:** are at the start corners 1, 2, and pits a tow vehicle will be positioned at near the start

22. **INSURANCE:** PUBLIC RISK INSURANCE is included under the permit for this Event. PERSONAL ACCIDENT INSURANCE - CAMS license holders are covered by Personal Accident Insurance for the term of the license. Refer to Appendix I of the Current CAMS Manual for further information on CAMS Insurance.

23. **PROTESTS:** Any protests must be made in accordance with Part XII of the NCR.

24. **POSTPONEMENT/ABANDONMENT/CANCELLATION:** The organisers reserve the right to postpone, abandon or cancel the Event in accordance with NCR 59.

#### 25. ALCOHOL: *Use of prohibited Substances*

During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the Current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Standard Operating Procedure for Alcohol Testing and CAMS Anti-Doping Policy. Competitors, crews or officials may be randomly tested for alcohol by a CAMS Accredited Testing Official (CATO) or other drugs at any time during the event(s).

#### **Other Prohibited Substances**

The CAMS Anti Doping Policy, as appears in the CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such.

In any areas where the National Competition Rules and the CAMS Anti Doping Policy conflict, the CAMS Anti Doping Policy will take precedence.

26. **REFRESHMENT FACILITIES** available: BBQ & DRINKS at the Finish Line & at the pits

27. **ADDITIONS AND/OR ALTERATIONS:** Any additions and/or alterations to these Supplementary Regulations will be notified to all Drivers in **Final Regulations** or during the **Drivers' Briefing**.

28. There is NO FUEL or WATER at the venue. Bulahdelah is approximately a 5km drive away.

29. All UNLOADING OF COMPETITION VEHICLES & TRAILER PARKING TO BE ON NORTH SIDE OF BOOLAMBAYTE CRK BRIDGE.

30. PITS: EACH COMPETITOR HAS SPACE FOR 2 VEHICLES ( SERVICE & COMPETITION) VISITORS OR EXTRA VEHICLES AS ABOVE.
